M/s Ideal Food Products availed Cash Credit facility from from Indian Bank, Apcar Garden Branch, Asansol (e-Allahabad Bank), and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Ideal Food Products failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 22/11/2011 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) M/s Ideal Food Products through its proprietor & mortgagor Sri Snehasis Sur S/o-Late Amrendra Nath Sur, Guarantor(s) Smt. Jhuma Sur, w/o-Sri Snehasis Sur liable to the Bank to pay the amount due to the tune of Rs. 32,37,344.00 (Rupees Thirty-Two Lakhs Thirty-Seven thousand three hundred and forty-four only) as on 22/11/2011 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 22/11/2011.

As M/s Idela Food Products failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 28/07/2012 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
