Union Bank of India, Chandganj (43720) Branch, B/16, Kursi Road, Kapurthala Chandganj, Lucknow, Uttar Pradesh- 226006, the secured creditor, caused a demand notice dated **18.04.2023** under Section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, calling upon you to pay the dues within the time stipulated therein.
