Smt Ravi devi W/o Sri Kamal Nayan shastri & Kamal Nayan Shastri S/o Shyam Narain Dubey availed **Housing** Loan facility from Indian Bank, Sasaram Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Smt Ravi devi W/o Sri Kamal Nayan shastri & Kamal Nayan Shastri S/o Shyam Narain Dubey failed to pay the outstanding dues to the Bank. As Smt Ravi devi W/o Sri Kamal Nayan shastri & Kamal Nayan Shastri S/o Shyam Narain Dubey failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **28.11.2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
