Mr. **Sanjay Kumar** availed Term Loan (Housing Loan) facility from Indian Bank, Hisar Green Square Market Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". liable to the Bank to pay the amount due to the tune of **Rs.13,78,716/- (Rupees Thirteen lakhs Seventy-Eight Thousand Seven Hundred & Sixteen Only)** as on 10.01.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 21.04.2022.

As Mr. **Sanjay Kumar** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 14.12.2022 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 10.01.2025 is of **Rs.13,78,716/- (Rupees Thirteen lakhs Seventy-Eight Thousand Seven Hundred & Sixteen Only)** with further interest, costs, other charges and expenses thereon from 10.01.2025.
