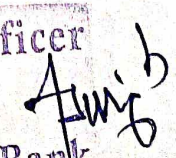

Mr. Akshay Balasaheb Patil (Borrower/Mortgagor) availed Home loan facility from Indian Bank, Pune NIBM Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Akshay Balasaheb Patil (Borrower/Mortgagor)** failed to pay the outstanding dues to the Bank.
