As Mr. Christofhar Sudhir George S/o Gladwin Sudhir George (Borrower/Mortgagor) & Mrs. Babita George W/o Christofhar Sudhir George (Co- Borrower/ Mortgagor) failed to make payment despite Demand Notice, the Authorized Officer took **Constructive /Symbolic/ Physical possession** of the schedule mentioned properties under the Act on 13.02.2019 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
