Mr Pankaj Maheshwari S/o Rajendra Maheshwari availed Home loan from Indian Bank Kasganj Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr Pankaj Maheshwari S/o Rajendra Maheshwari failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 16.03.2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) mentioned above liable to the Bank to pay the amount due to the tune of **Rs.48,76,321 (Rupees Forty Eight Lakhs Seventy Six Thousand Three Twenty One Only)** as on 16.03.2022 with further interest, costs, other charges and expenses thereon. You have failed to make payment despite Demand Notice dated 16.03.2022.

As Mr Pankaj Maheshwari S/o Rajendra Maheshwari failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 01.07.2022 after complying with all legal formalities. As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

The amount due as on 16.03.2022 is **Rs.48, 76,321 (Rupees Forty Eight Lakhs Seventy Six Thousand Three Twenty One Only)** with further interest, costs, other charges and expenses.

The date of sale is fixed as **19.05.2026** which would be by e-auction mode.
