Shri Mohd Sajid S/o Mr. Shafiq Ahmad availed **Housing Loan Advantage & IB Home Improve loan account** from **Indian Bank Amroha Branch**, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Shri Mohd Sajid S/o Mr. Shafiq Ahmad** failed to pay the outstanding dues to the Bank.
