Mr. Mohammed Ameen Chalayil and Mrs. Nabeesa Kasim availed Home Loan facility from Indian Bank, M G Road (Ernakulam) Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Mohammed Ameen Chalayil and Mrs. Nabeesa Kasim failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 07.01.2025 (published in newspaper on 21.01.2025) under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Mr Mohammed Ameen Chalayil (Borrower) and Mrs. Nabeesa Kasim (Co-borrower) liable to the Bank to pay the amount due to the tune of Rs. 96,22,342.00 /- (Rupees Ninety Six Lakhs Twenty Two Thousand and Three Hundred and Forty Two only) as on 06.01.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 07.01.2025.

As Mr. Mohammed Ameen Chalayil and Mrs. Nabeesa Kasim failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 24.03.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. The amount due as on 31.05.2025 is **Rs. 99,74,392/- (Rupees Ninety Nine Lakhs Seventy Four Thousand Three Hundred and Ninety Two Only)** with further interest, costs, other charges and expenses thereon from 01.06.2025.

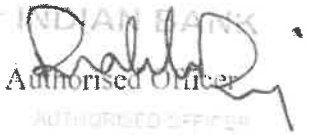
