NOTICE OF SALE

Notice of sale under Rule 6(2) & 8(6) of The Security Interest (Enforcement Rules) 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Sub: Loan account – HL-ELITE-NRI-CBL >=800 (A/c No 7536255440) of Mr. Sali P S with Indian Bank, M G Road (Ernakulam) Branch

Mr. Sali P S availed Home Loan facility from Indian Bank, M G Road (Ernakulam) Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Sali P S failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 07.02.2025 (published in newspaper on 15.02.2025) under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Mr. Sali P S (Borrower) and Mr. Sunesh Sundaran (Guarantor) liable to the Bank to pay the amount due to the tune of Rs. 98,11,769/- (Rupees Ninety Eight Lakhs Eleven Thousand and Seven Hundred and Sixty Nine only) as on 06.02.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 07.02.2025.

As Mr. Sali P S and Mr. Sunesh Sundaran failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 23.04.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 20.06.2025 is Rs. 1,01,46,719 /- (Rupees One Crore One Lakh Forty Six Thousand Seven Hundred and Nineteen Only) with further interest, costs, other charges and expenses thereon from 21.06.2025.

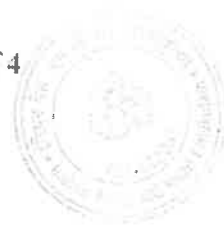
The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The terms and conditions of e-auction is available in the website (<https://baanknet.com>).

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by 27.07.2025, i.e the e-Auction Date and before the e-auction end time in the portal. 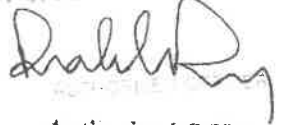
