

Coracle tender violation row erupts again in Hampi

THE controversy surrounding coracle rides at Chakratirtha on the Tungabhadra river are under scrutiny for allegedly flouting guidelines prescribed by both UNESCO and the Archaeological Survey of India (ASI). The norms reportedly restrict the use of traditional coracles in certain sensitive stretches near heritage structures, favouring regulated mechanised boat services to minimise ecological and structural impact. Despite these norms, coracle rides have continued in the area for the past few years, with authorities accused of lax enforcement. The issue has

gained renewed attention following the recent renewal of operational tenders by the Vijayanagara district administration.

Tarhihalli Hanumanthappa, district president of the Karnataka Rakshana Vedike (T A Narayana Gowda faction), has accused operators of flouting tender norms by continuing coracle rides despite clear conditions that only permit mechanised boats to ferry passengers from one bank to another.

In his complaint, Hanumanthappa has urged authorities to

immediately cancel the tender, stating that the ongoing activities violate the prescribed rules. He also alleged that tourists are being charged arbitrarily, ignoring the officially displayed tariff of Rs 100 for adults and Rs 50 for children for mechanised boat services. A senior official of Vijayanagara district administration clarified that only mechanised boating is allowed and coracle rides are strictly prohibited under the tender conditions. He said authorities will keep a close watch on such violations.
