7. The interested bidders, who have submitted their EMD not below the Reserve Price before **01.00 P.M** on 07.05.2026, shall be eligible for participating in the e-bidding



process. The e-auction of above property would be conducted exactly on the scheduled Date & Time as mentioned against the property by way of inter-se bidding amongst the bidders. The bidder shall improve their offer in multiple of the amount mentioned under the column "Bid Increase Amount" against the property. In case bid is placed in the last 5 minutes of the closing time of the e-auction, the closing time will automatically get extended for 5 minutes **(subject to Unlimited Auto extensions of 10 minutes each)**.
