1. This has reference to recovery actions initiated against you under the provisions of the SARFAESI Act 2002.

1. The property will be sold by e-auction through the service provider <https://baanknet.com> under the supervision of the Authorized Officer of the Bank.
2. The intending Bidders /Purchasers are requested to register on portal <https://baanknet.com> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by **26.05.2026 before 10.00AM** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
3.
