TERMS AND CONDITIONS

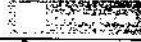
The sale shall be subject to the Terms & Conditions prescribed in the Security Interest (Enforcement) Rules 2002 and to the following further conditions:

1. The auction sale will be "online through e-auction" portal <http://www.baanknet.com> on 26.05.2026 @ 11.00 AM to 4.00 PM
2. The intending Bidders/ Purchasers are requested to register on portal (<https://www.baanknet.com>) by using their mobile number and email-id. Further, they are requested to do "Buyer registration" through Digi-locker. The intending Bidders/ Purchasers then have to credit amount in his E-Wallet through online or by Chalan (www.baanknet.com site generated) through bank.
3. The intending Bidders/ Purchasers are requested participate by transferring EMD amount from e-wallet before EMD end date and time as mentioned in the www.baanknet.com.
4. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through 3 mode i.e. NEFT/ Cash/ Transfer (After generation of Challan (<https://www.baanknet.com>) in bidders E-Wallet. NEFT transfer can be done from any Scheduled Commercial Bank, however for Cash/ Transfer the bidder has to visit Punjab National Bank Branch. Payment of EMD by any other mode such as Cheques will not be accepted. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. 9. Bidder's E-Wallet should have sufficient balance ($\geq$ EMD amount) at the time of bidding.

During the e-auction bidders will be allowed to offer higher bid in inter-se bidding over and above the last bid quoted and the minimum increase in the bid amount must be of Rs.10,000.00 higher bid of the bidders. If any bid comes within the last Five minutes before the bidding expiry time, then another Five minutes time will be allowed to bidders to quote successive higher bid, and it will continue unless no higher bid is offered by any bidder after the expiry of Five minutes to the last highest bid. Then the e-auction shall be closed.
