1. The property(ies) will be sold by e-auction through the Bank's approved service provider baanknet (psballiance) under the supervision of the Authorized Officer of the Bank.

3. Intending bidders shall hold a valid digital signature certificate and email address and should register their name / account by login to the website of the aforesaid service provider. They will be provided with user id and password by the aforesaid service provider which should be used in the e-auction proceedings. 4. Bids in the prescribed formats shall be submitted "online" through the portal - (<https://baanknet.com/>) along with the EMD & scanned copy of KYC documents including photo, PAN Card & address proof to the service provider and the Authorised Officer before 04.00PM hours on 25/05/2026
