As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 6 (2), Rule 8(6) and Rule 9 (1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice. The amount due **Rs. 31,16,873.44 (Rupees Thirty One Lacs Sixteen Thousand Eight Hundred Seventy Three and Paise Forty Four only)** as on **20.04.2025**, with further interest, charges & expenses thereon due to the Indian Bank.

The date of sale is fixed as 15.05.2026 which would be by e-auction mode.
