Mr Sunil C P S/o Mr Gopalan C K and Mrs Ambilikumary T, W/o Mr Sunil C P availed Home loan and clean salary loan facility from Indian Bank, NRI Ranni Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr Sunil C P and Mrs Ambilikumary T failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 01/11/2021 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon above mentioned Borrower(s), Guarantor(s) liable to the Bank to pay the amount due to the tune of **Rs 53,19,631/- (Rupees Fifty-three lakh nineteen thousand six hundred and thirty-one only)** as on 20/04/2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 01/11/2021.

As Mr Sunil C P and Mrs Ambilikumary T failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 31/01/2022 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

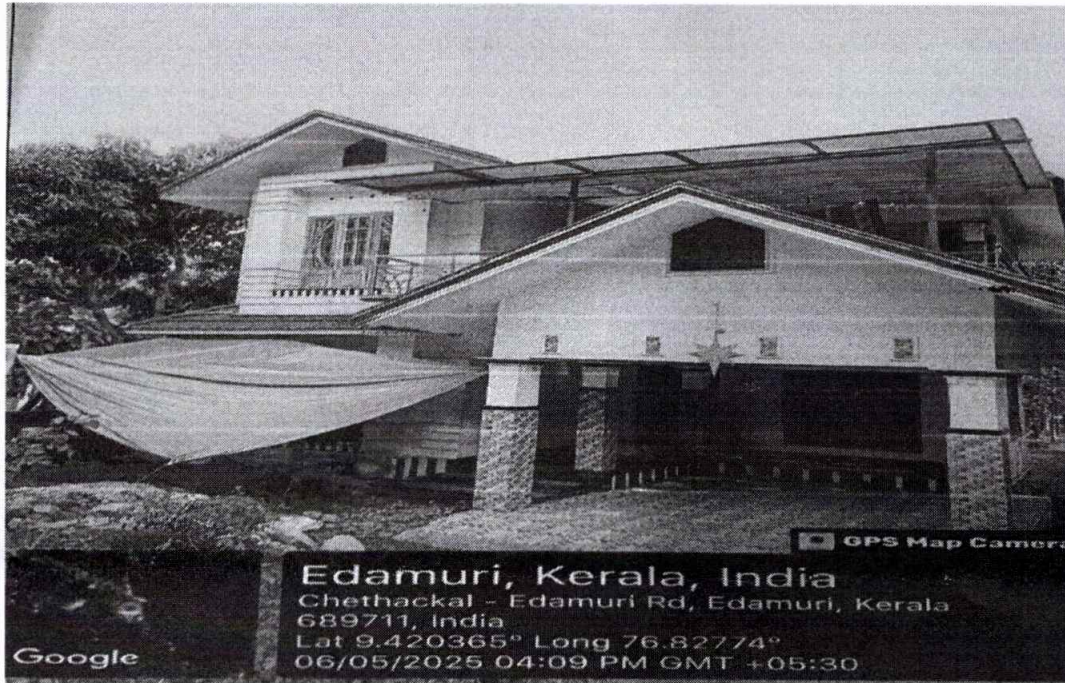
