E-AUCTION SALE NOTICE

1. The property(ies) will be sold by e-auction through the service provider <https://www.psballiance> under the supervision of the of the Authorized Officer of the Bank.
2. The intending Bidders /Purchasers are requested to register on portal <https://BAANKNET.com> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents.
