



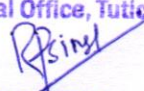

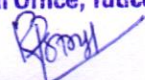

Terms and Conditions

Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account **by 25/05/2026**. Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
