Mrs. Sharmila Bapu saheb Dhumal availed Loan facilities from Indian Bank Laxmi Road Pune Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mrs. Sharmila Bapu saheb Dhumal failed to pay the outstanding dues to the Bank. Both failed to make payment despite Demand Notice dated 07.11.2025.

As you have failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on after complying with all legal formalities and symbolic possession taken on 22.01.2026.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
