This is without prejudice to any other rights available to the Bank under the subject Act/ or any other law in force.

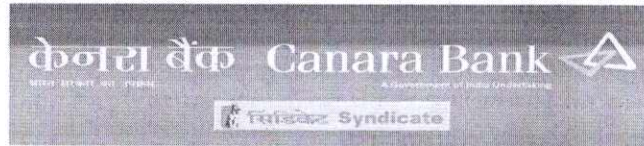
