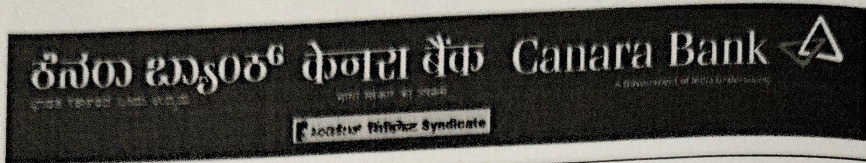

- d. 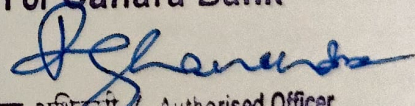
