SUZHOU (CHINA)
India lose to Australia in U17 Women's Asian Cup
India went down fighting 0-2 against Australia in their opening group match of the AFC U17 Women's Asian Cup football tournament here on Saturday. Theodora Mouthys put Australia ahead in the 25th minute before Indian defender Abhista Basnett scored an own goal in the 59th minute in the opening Group B match. India face four-time champions Japan on May 5 before taking on Lebanon on May 8. It is India's first appearance at the U17 Women's Asian Cup since 2005.

Kuldeep smashes pole vault national record
Madhya Pradesh pole vaulter Kuldeep Kumar smashed the national record by clearing 5.41m as he stunned his more fancied rivals for the title on the opening day of the inaugural Indian Indoor Open Combined Events and Pole Vault Competition here on Saturday. The 21-year-old, who was competing in his first indoor event, got the winning jump in his first attempt. He bettered the national record of 5.40m set last year by another Madhya Pradesh athlete Dev Kumar Moena, who himself ended at the third spot with an effort of 5.20m.

Jacobs powers NZ to 6-wicket win over Bangladesh
Bevon Jacobs hit his maiden half-century as New Zealand recovered from a shaky start to beat Bangladesh by six wickets in the rain-hit third T20 on Saturday, concluding the three-match series at 1-1. Jacobs' 31-ball 62 not out, including five fours and three sixes, helped his side reach 104/4 in 11.4 overs, chasing down Bangladesh's 102 all out in 14.2 overs. Bangladesh had won the first match by six wickets. The second match was rained out.

Yuvraj in Top-10 in Turkey, Sharma also makes cut
India's Yuvraj Sandhu played a steady round of 1-under 71 and was inside the Top-10 at the halfway stage of the Turkish Airlines Open on DP World Tour title here. Also making the cut was Shubhankar Sharma, despite a nightmarish finish as he dropped five shots in a span of five holes between the 13th and the 17th with three bogeys and a double bogey. He shot a 3-over 75 and was now 1-over and tied-57th. Gregorio De Leo will take a one-shot lead into the weekend.

Dhamne makes maiden ATP Challenger final
India's rising tennis talent Manas Dhamne scripted a breakthrough run by storming into his maiden ATP Challenger final with a straight-set win over France's Antoine Ghibaud in Shymkent, Kazakhstan, on Saturday. The 18-year-old Indian produced a composed and aggressive display to pip Ghibaud 6-4 6-3 in the semifinals of the clay court tournament.

Bayern score in stoppage time to rescue 3-3 draw
Bundesliga champions Bayern Munich scored through Michale Olise with the last kick of the game to snatch a 3-3 draw against bottom club Heidenheim in the league on Saturday, after battling back from two goals down. Bayern coach Vincent Kompany rotated his side heavily after Tuesday's 5-4 loss to Paris St Germain in their Champions League semifinal first leg and ahead of next week's return match in Munich. Gaikwad, Kartik and bowlers help Chennai beat Mumbai to boost playoff prospects

CHENNAI, MAY 2
Chennai Super Kings produced a thoroughly professional display to outclass Mumbai Indians by eight wickets in a critical Indian Premier League match and significantly boost their playoff prospects.
Afghanistan left-arm spinner Noor Ahmad led a disciplined bowling effort to help CSK restrict a lacklustre Mumbai Indians to 159/7. Noor returned excellent figures of 2/26 in four overs while Anshul Kamboj grabbed 3/32, even as Naman Dhir top-scored for MI with 57 off 37 balls in an insipid display by the visitors after winning the toss. Captain Hardik Pandya consumed 23 balls for his 18, reflecting MI's struggles.
Pandya's counterpart Ruturaj Gaikwad then led by example with an unbeaten 48-ball 67 and he was well supported by Kartik Sharma (54 not out off 40 balls) and Urvil Patel (24 off 12 balls). — PTI

For a side that had set the early pace with six wins on the trot, the loss has brought a few concerns, especially with the ball.

Yastika, uncapped Nandini named in T20 World Cup squad

MUMBAI, MAY 2
India on Saturday drafted in Bharti Fulmali, wicket-keeper-batter Yastika Bhatia and uncapped Nandini Sharma in the 15-player squad for the upcoming three-match T20I tour of England followed by the Women's T20 World Cup, starting on June 12.
While specialist batters Pratika Rawal and Harleen Deol were excluded, all-rounder Amanjot Kaur and seamer Kashvee Gautam missed out on selection owing to injuries. Harmanpreet Kaur will lead the Indian side with Smriti Mandhana being her deputy.
Pratika, however, has been named in the squad for the one-off Test against England to be played at the Lord's on July 10-13 where Harleen will lead the India A side in the white ball tour to England.
The selectors preferred Yastika's experience and skills behind the wickets over Pratika. "There was a discussion on it," chairperson of selectors Amita Sharma said. "Since Yastika is more experienced and also gives an option of being a top-order batter along with being a wicketkeeper, so we went in that direction," Sharma added.
Medium pacer Nandini was handed her maiden

India call-up after doing well in WPL, where she played 10 matches for Delhi Capitals, taking 17 wickets. She was also part of the India squad that played in the Women's Asia Cup Rising Stars tournament in Bangkok in February.
The fast bowling line-up also does not feature Pooja Vastrakar, as Renuka Singh Thakur will continue to lead the pace attack with Arundhati Reddy and Kranti Gaud behind her.
Harmanpreet said Amanjot has been sidelined for the next "4-5 months". "Amanjot is one of our key players but unfortunately she is not available," she said. "It was very difficult to find someone in her place but we will try someone like Bharti, whatever opportunities she has got, she has tried to prove herself," she added.
The core squad is similar to the one which won the ODI Women's World Cup in November last year.
Mandhana, Shafali Verma and Jemimah Rodrigues are expected to form the top three while the inclusion of Bharti, who did an impressive job lower down the order in the WPL, will help in completing the batting line-up along with other finishers such as Richa Ghosh and Deepti Sharma. — PTI
