Mr. Jahid Yunusbhai Jagrala availed HL-ADVTGE-RESFLOT75L MCLR from Indian Bank, Manor Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Jahid Yunusbhai Jagrala failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 22.09.2020 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Mr. Jahid Yunusbhai Jagrala to the Bank to pay the amount due to the tune of Rs. 14,40,252.00/- (Rupees Fourteen Lakh Forty Thousand Two Hundred Fifty Two Only) as on 22.09.2020 with further interest, costs, other charges and expenses thereon. Mr. Jahid Yunusbhai Jagrala failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 02.06.2023 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
