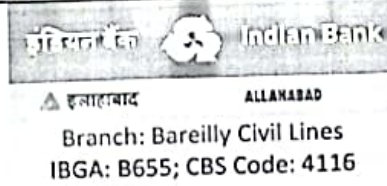

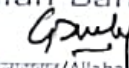

M/s. Salma Khan and M/S Karamat Zari Arts availed credit facilities from Indian Bank Bareilly civil lines Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s. Salma Khan and M/S Karamat Zari Arts failed to pay the outstanding dues to the Bank. 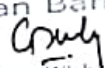

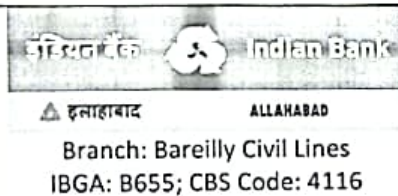
