Mrs. S. Durgadevi W/o. S.R.Sivalingam availed Loan facilities from Indian Bank, Karaikal Branch. The repayment of loan is secured by Mortgage of schedule mentioned properties. Mrs. S. Durgadevi W/o. S.R.Sivalingam failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 09.04.2018 under Sec. 13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s) and Guarantor(s), liable to the Bank to pay the amount dues to the tune of **Rs.26,08,531/- (Rupees Twenty Six lakh eight thousand five hundred thirty one Only)** as on 09.04.2018 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 09.04.2018.

As the borrower **Mrs. S. Durgadevi W/o. S.R.Sivalingam** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 18.09.2018 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends to sell the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER / AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6(2) and 8(6) and 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 29.04.2026 is **Rs. 99,23,133/- (Rupees Ninety Nine lakh twenty three thousand one hundred and thirty three Only)** with further interest, costs, other charges and expenses thereon from 30.04.2026.

Please take note that this is notice of **15 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **15 days**.

The date of sale is fixed as 18.05.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc may be done by the intending purchasers/bidders at their expenses **from 30.04.2026 to 14.05.2026 from 10.00 am to 4.00 pm.**

Ltd.) **for depositing in bidders EMD Wallet.** NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted.** Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/ cancel the sale without assigning any reason there of.
