Mrs. Vaishali Santosh Rahere and others had availed **RBD** facilities mentioned above from Indian Bank, Nasik Ambad Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. **Mrs. Vaishali Santosh Rahere** and others had failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **20.08.2025** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) **Mrs. Vaishali Santosh Rahere** and others liable to the Bank to pay the amount due to the tune of amounts as on **20.08.2025** amounts to **Rs. 37,17,169/- (Rupees Thirty Seven Lakhs Seventeen Thousand One Hundred Sixty Nine only)** and the said amount carries further interest at the agreed rate from **21.08.2025** all the borrower and mortgagor, guarantors failed to make payment despite Demand Notice dated 21.08.2025.

As you have failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on after complying with all legal formalities and symbolic possession taken **on 17.11.2025**.



As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

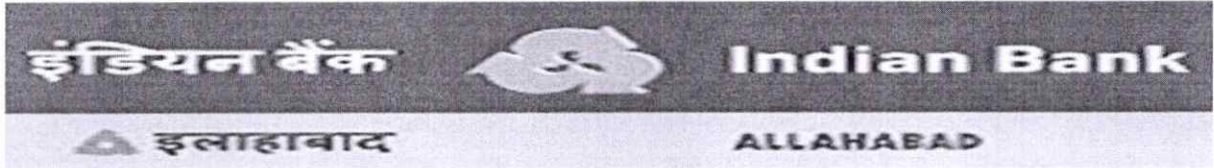
