E-Auction Sale Notice

SALE OF IMMOVABLE PROPERTY MORTGAGED TO THE BANK UNDER THE

Whereas **i) Mr.Kripesh Kunwar S/o Sushil Kunwar & Mrs. Lalti Devi W/o Kripesh Kunwar** ,have borrowed monies from Indian Overseas Bank against the mortgage of the immovable property more fully described in the schedule hereunder and on upon classification of the account as NPA, the Bank has issued a **Demand Notice** to the Borrowers under Section 13(2) of the SARFAESI Act, 2002 (Act) on **05.06.2025** calling upon the borrowers i) **Mr.Kripesh Kunwar S/o Sushil Kunwar & Mrs. Lalti Devi W/o Kripesh Kunwar** to pay the amount due to the Bank, being **Rs.37,91,036.10 (Rupees Thirty Seven Lakhs Ninety One Thousand Thirty Six and Ten Paisa only)** as on 05.06.2025 payable together with further interest, at contractual rates and rests along with costs and charges etc till date of repayment, within 60 days from the date of receipt of the said notice.

Whereas the borrower having failed to pay the amount dues in full to the bank as called for in the said demand notice, the bank has taken possession of the secured assets more fully described in the schedule hereunder on 07.10.2025 under Section 13(4) of the Act with the right to sell the same in "As is where is" and "As is what is" basis under section 13(4) of the Act read with the rules 8&9 of the Security Interest (Enforcement) rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as **Rs.38,67,603.10/- (Rupees Thirty Eight Lakhs Seventy Seven Thousand six Hundred Three and Ten Paisa only) as on 07.10.2025** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower **as on 31/10/2025 is Rs.38,95,524.10/- (Rupees Thirty Eight Lakhs Ninety Five Thousand Five Hundred Twenty Four and Ten Paisa Only)** along with further interest after reckoning repayments if any, subsequent to the bank issuing the demand notice.

2. The intending Bidders /Purchasers are requested to register on portal **URL: <https://baanknet.com/eauction-psb/bidder-registration>** using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers have to transfer the EMD amount using online mode in their Global EMD Wallet account by **26.05.2026 before 02.45 P.M** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.

3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/RTGS mode (After generation of Challan from **URL: <https://baanknet.com/eauction-psb/bidder-registration>** which will provide account details) in bidders Global EMD Wallet account. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. Bids without EMD shall be rejected summarily. 7. Online auction sale will start automatically on and at the time as mentioned above. Auction / bidding will initially be for a period of 60 Minutes with auto extension time of 5 minutes each till the sale is concluded.
8. During the e-auction bidders will be allowed to offer higher bid in inter-se bidding over and above the last bid quoted and the minimum increase in the bid amount must be of **Rs.50,000/-** to the last higher bid of the bidders. **10 minutes'** time will be allowed to bidders to quote successive higher bid and if no higher bid is offered by any bidder before the expiry of 10 minutes to the last highest bid, the e-auction shall be closed.
9. The property shall be sold to the successful bidder.
