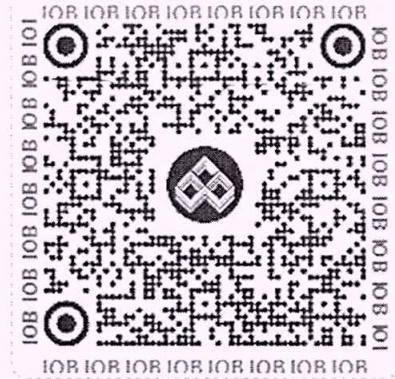

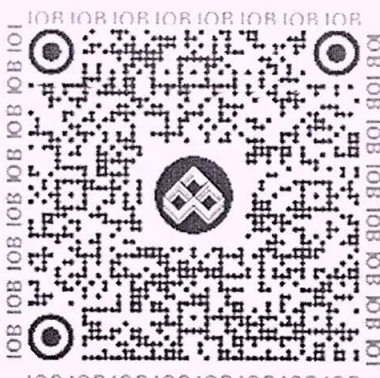

The dues to the bank as on the date of taking possession was intimated as **Rs. 58,02,306.75 (Rupees Fifty-Eight Lakh Two Thousand Three Hundred Six and Seventy-Five Paise Only)** as on **28/11/2019** payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

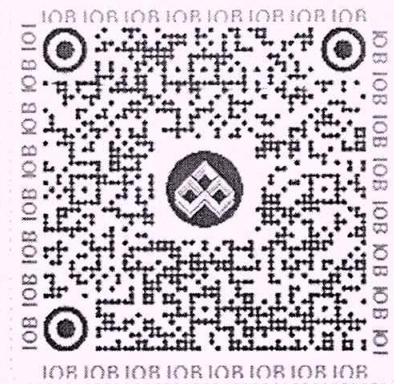
