TERMS AND CONDITIONS OF E-AUCTION SALE

1. **The sale shall be subject to the Terms & Conditions prescribed in the Security Interest (Enforcement) Rules 2002 and to the following further conditions. The auction sale will be “online through e-auction” portal <https://www.ebkray.in>**
