15. EMD of the unsuccessful bidders will be returned through EFT/ NEFT/ RTGS to the bank account details provided by them in the bid form and intimated via their e-mail id.
16. The e-auction advertisement does not constitute and will not be deemed to constitute any commitment or any representation by the bank. The **Authorised Officer/Secured Creditor shall not be responsible in any way for any third party claims / rights / dues.**
17. **When a single bid has been received, the bid should be higher than the reserve price. According to the SARFAESI Rule 9, sale will not be confirmed if the bid price is less than or equal to reserve price.**
18. *In compliance with Section 194 IA of the Income Tax Act, 1961 income tax @ 1 % on the Reserve Price shall be deducted and paid under the PAN of the Purchaser.
