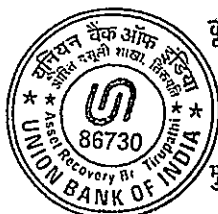

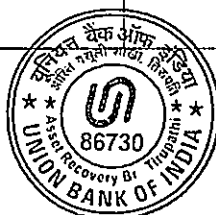

10.1. Registration

11.
