

# Tharoor moves HC for blocking of AI videos showing Pak praise

New Delhi: Congress MP Shashi Tharoor Friday moved the Delhi high court against publication of AI-generated deepfake videos that show him praising Pakistan and making statements on "politically sensitive" issues, and sought protection of his personality rights.

After hearing Tharoor's submissions, Justice Mini Pushkarna issued summons to social media intermediaries X and Meta, as well as the Centre, and indicated she would pass an interim order in his favour.

## PROTECTION OF PERSONALITY RIGHTS

In his lawsuit, the Thiruvananthapuram MP submitted that unknown entities were repeatedly publishing fake videos by misappropriating his face, voice and other attributes of his personality, and sought directions that

these be taken down. Tharoor submitted that the videos harmed his reputation as a patriot and chairperson of the parliamentary standing committee on external affairs.

Although mainstream news publications prominently put out that these were fake videos, the public continued to have the impression that these are authentic, he pointed out.

liable to be misused by foreign states," Tharoor said, adding that even though the authorities took down several offending URLs following a grievance raised by him under the IT Rules and to the police, the content kept resurfacing.

Tharoor highlighted that in March, he discovered a "sophisticated, malicious campaign orchestrated by unknown infringers" across social media platforms, depicting him making statements praising Pakistan.

## Companies purchasing costlier oil and gas from global market

The rupee cost has shot up further due to the currency weakening against the dollar. "Oil companies are purchasing costlier oil and gas from the global market, but selling it at lower prices. It is impacting their finances. That's why govt reduced the excise duty on petrol and diesel, which is costing it Rs 14,000 crore a month," Sharma said. But with refiners bleeding for 11 weeks, losses are not sustainable indefinitely especially amid projections that prices will remain elevated for at least four months even if a permanent ceasefire was announced now.

While govt has reduced excise duty on petrol (Rs 13 a litre) and diesel (Rs 10), it has limited headroom. Govt will have to bear the subsidy on domestic cooking gas cylinders.

Govt and oil companies will, however, have to decide on the extent of the increase. Besides, a steep rise in petrol prices will stoke headline inflation, with retail inflation currently at 3.4%.

In an address at a seminar on "New Age Military Technologies" organised by industry chamber FICCI in July last year, Lt Gen Singh suggested that China used its satellites to monitor Indian military deployment in the Pakistani military was getting line inputs on it during the DGMO-level phone talks.

The Deputy Chief of Army Staff likened China's strategy during Operation Sindoor to its ancient military strategy of "36 stratagems" and killing the adversary with a "borrowed knife" to buttress the point that Beijing extended all possible support to Pakistan to cause pain to India.

Chinese officials and social media played up Pakistan's claims of shooting down Indian fighter planes to showcase Chinese tech superiority even though there was no evidence to support Islamabad's assertion.

But Chinese officials and media remained silent about Pakistan suffering heavy collateral damage, including several terrorist headquarters, key air bases and failure

of Chinese radars, which enable India's air superiority. Latest media reports here said China plans to sell its stealth bomber J-35 to Pakistan.

The disclosures by the Chinese officials about China's assistance to Pakistan during the May conflict with India are seen as a new "sales pitch", observers said.

Xu Da, another employee from the Chengdu Aircraft Design and Research Institute, who also provided on-site support to Pakistan during the war, compared the J-10CE jet to a "child".

"We nurtured it, cared for it, and finally handed it over to the user. And now, it is facing a major test," Xu said. "As for the outstanding results the J-10CE achieved, we were very surprised, and it didn't feel sudden at all. In fact, it felt inevitable. The aircraft just needed the right opportunity. And when that moment came, it delivered exactly as we knew it would," he added.

The J-10CE is the export variant of the J-10C 4.5-generation fighter and is considered the most advanced model in the J-10 series.
