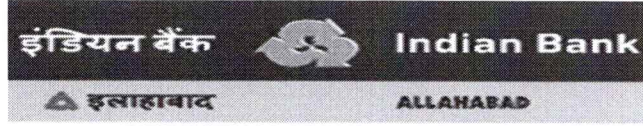

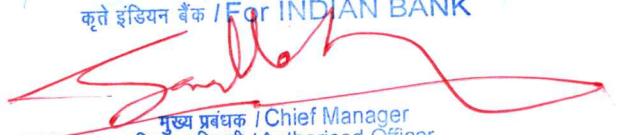
M/s Ammoos Medicals availed aforesaid loan facility from Indian Bank, Perinthalmanna Branch, represented by Mr Mohanan (Managing Partner), Mr Vijayan (Partner) and Mr Ramesh Babu T (Partner) the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Ammoos Medicals, Mr Mohanan (Managing Partner), Mr Vijayan (Partner) and Mr Ramesh Babu T (Partner) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 14.02.2020 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Mr Mohanan (Managing Partner), Mr Vijayan (Partner) and Mr Ramesh Babu T (Partner) are liable to the Bank to pay the amount due to the tune of Rs.2200945/- as on 12.12.2020. with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 14.02.2020.

As M/s Ammos Medicals failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 16.07.2021 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode.
