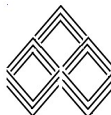

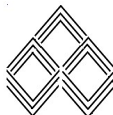

Whereas the borrowers & guarantors having failed to pay the amount dues in full to the Bank as called for in the said demand notice, the Bank has taken possession of the secured assets more fully described in the schedule hereunder on **06.02.2023** under Section 13 (4) of the Act with the right to sell the same in **“As is where is” ,“As is what is”** and **“Whatever there is”** basis under Section13(4) of the Act read with Rules 8 &9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank’s dues. The dues to the bank as on the date of taking possession was intimated as **Rs.10,76,19,692/- (Rupees Ten Crore Seventy Six Lakhs Nineteen Thousand Six Hundred Ninety Two only)** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on **07.05.2026** works out **Rs.12,85,94,689/- (Rupees Twelve Crores Eighty Five Lakhs Ninety Four Thousand Six Hundred and Eighty Nine Only)** after



reckoning repayments, **Rs.2,38,85,173/78 (Rupees Two Crores Thirty-Eight Lakhs Eighty Five Thousand One Hundred and Seventy Three and Paise Seventy Eight Only)** subsequent to the Bank issuing demand notice.

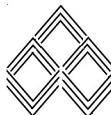

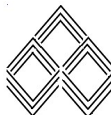
