M/s **M/s Sri Venkateswara Modern Rice Mill** availed **IB Star Agro Mill, IND-KIF-MON** facility from Indian Bank, Alangulam Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. **M/s Sri Venkateswara Modern Rice Mill** failed to pay the outstanding dues to the Bank. the tune of **Rs.57,42,781.00/- (Rupees Fifty-Seven Lakhs forty-two thousand seven hundred and eighty-one only Only)** as on **15.04.2025** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 16.04.2025

As **M/s Sri Venkateswara Modern Rice Mill** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 03.07.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 27.04.2026 is **Rs.66,88,995/- (Rupees Sixty-Six Lakhs Eighty-Eight Thousand Nine Hundred and Ninety-Five Only)** with further interest, costs, other charges and expenses thereon from 28.04.2026

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 15.05.2026 which would be by e-auction mode.
