Foreign language skills key to new jobs: Pradhan

Rajasthan signs MoUs to boost foreign language skills and enhance youth employability through global education initiatives.

NEW DELHI: The Rajasthan government has signed MoUs with several institutions, including the English and Foreign Languages University and the National Skill Development Corporation, during a ceremony for the Foreign Language Communication Skills Programme at Birla Auditorium in Jaipur. Speaking on the occasion, Union Education Minister Dharmendra Pradhan said Rajasthan's youth possess a natural aptitude for hard work, innovation, entrepreneurship, and cultural adaptability.



Inspired by Prime Minister Narendra Modi, he noted, young people are increasingly focusing on skill development rather than just academic degrees. Pradhan highlighted that the proposed free trade agreement with the European Union could create new employment opportu-

nities linked to foreign language proficiency. He emphasised that language is not merely a tool for communication but also a means of understanding and connecting societies. Referring to the National Education Policy 2020, he said it is a key step towards build-

First Phase of House Listing from 22 in UP

LUCKNOW: In Uttar Pradesh, the first phase of Census 2027, focused on house listing, will begin on 22nd of this month. A self-enumeration facility will be available from 7th of May. During a press conference in Lucknow, State Director of Census Operations and Chief Principal Census Officer, Sheetal Verma, said, citizens can take part through the self-enumeration facility by registering on the official website from 7th of this month. After completing the process, they will receive a unique code, which must be shared with the enumerator during the home visit. Ms Verma said, Uttar Pradesh will conduct the first phase of Census 2027, focused on house listing, from 22nd of May to 20th of June.

Shivraj begins PMGSY projects worth Rs 1,700 crore in Odisha

BHUBANESHWAR: The Centre has unveiled a wide-ranging rural development package for Odisha, with a strong



focus on connectivity, housing and livelihoods, as Union Minister Shivraj Singh Chouhan and Chief Minister Mohan

Charan Majhi jointly launched key initiatives in Rayagada. The highlight of the programme was the roll-out of the fourth phase of the Pradhan Mantri Gram Sadak Yojana (PMGSY-IV), under which 827 new roads spanning about 1,702 km will be built at a cost of nearly Rs 1,700 crore. The projects aim to connect remote and hilly regions, improving access to essential services and boosting local

economies. The Union Minister also handed over the formal approval letter for PMGSY-IV to the Chief Minister during the event. The Centre further approved Rs 630.61 crore for completing pending rural houses under PMAY-G, Rs 868.71 crore as the first instalment under MGNREGA for 2026-27, and Rs 30.07 crore under WDC-PMKSY 2.0 for watershed development.

PM wishes fast recovery to UP Cong chief Ajay Rai

NEW DELHI: Prime Minister Narendra Modi on Friday expressed concern over the health of Uttar Pradesh Congress president Ajay Rai, wishing him a speedy recovery after reports of his illness surfaced.

Taking to the social media platform X, PM Modi said, "I have received the news of Uttar Pradesh Congress president Ajay Rai ji being unwell. I pray for his speedy recovery with good treatment." According to reports in the state Congress unit, Ajay Rai was admitted to a hospital in Varanasi after he complained of sudden health complications, including weakness and fluctuating blood pressure. Doctors attending to him said his condition is currently stable, but he remains under observation for further evaluation and monitoring.

Congress leaders said Rai had been actively engaged in organisational activities and public outreach programmes in recent days, which may have contributed to fatigue. He reportedly experienced discomfort late Thursday evening and was taken to a local medical facility, where pre-

liminary tests were conducted. Senior Congress leaders in Uttar Pradesh have been visiting the hospital and are in constant touch with doctors. Party workers have also expressed concern over his health, with several leaders taking to social media to extend their wishes for his recovery.

Ajay Rai, a prominent political figure from eastern Uttar Pradesh and a former MLA from Varanasi, has been at the forefront of the Congress party's efforts to strengthen its base in the state. His illness comes at a time when political activity in Uttar Pradesh is intensifying ahead of the upcoming electoral engagements.
