

Post-poll flare-ups rock Bengal, BJP calls for calm

Kolkata: Post-election flare-ups across Bengal triggered clashes, firing and vandalism from Kolkata to its northern fringes, prompting BJP brass to call for restraint and direct its cadre to restore calm on the ground.

The most serious confrontation came from Sandeshkhali in North 24 Parganas district, roughly 75km northeast of Kolkata, where a clash between Trinamool and BJP supporters over control of a bheri (fish pond) left three policemen and two CRPF personnel wounded by gunfire.

Police said armed groups converged near the fishery around 10.30pm Tuesday. Officers and central forces responding to a tip-off were caught in crossfire. The officer-in-charge suffered a bullet wound to his leg.

"As police rushed in darkness, miscreants opened fire," said Barasat IG Amit Javalgi, adding four people were arrested and firearms, explosives and cartridges seized. The region, once a Trinamool stronghold, saw BJP's Sanat Sardar win the seat in 2026 assembly polls, underscoring the shifting electoral ground.

Tiljala in east Kolkata after allegations that miscreants abused and assaulted local women led to a two-and-a-half-hour standoff late Tuesday. Newly elected Kasha MLA Javed Ahmed Khan rushed in to defuse the situation after the daughter of one of his staff was allegedly assaulted and molested.

"We strongly condemn the brutal attack carried out by BJP-backed miscreants... innocent locals were beaten and property vandalised," Khan said. BJP denied involvement, urging police to act firmly.

Kolkata police commissioner Ajay Nand said two cases were registered, 40 accused were arrested and additional forces deployed.

CEC orders arrest of those involved in post-poll violence

Kolkata: Chief Election Commissioner Gyanesh Kumar directed the authorities concerned to immediately arrest those involved in post-poll violence and vandalism in West Bengal, an official said on Wednesday.

The EC's directive came after two persons were killed in alleged incidents of post-poll violence in the state on Tuesday, besides scores of party offices being ransacked.

The CEC issued instructions to the West Bengal chief secretary, director general of police, Kolkata police commissioner and directors general of central armed police forces, along with all district magistrates, superintendents of police and other officials, to maintain continuous patrolling in sensitive areas, he said.

"Those responsible for inciting violence and carrying out acts of vandalism must be arrested immediately," the official said, quoting the CEC's instruction. The chief election commissioner also stressed the need for swift and firm enforcement of the law, he added. This directive came amid concerns over law and order in parts of the state, with the Election Commission closely monitoring the situation, he added.

Bengal police whip on bulldozers, pol rallies after EC nudge

Kolkata: Bulldozers will not be allowed in victory processions and political rallies, Bengal DGP SN Gupta and Kolkata Police commissioner Ajay Nand said Wednesday, after CEC Gyanesh Kumar directed authorities to arrest those involved in post-poll violence following two deaths and reports of widespread vandalism.

If any cop is found to have "not acted enough" to stop illegal demolitions despite being present, action will follow, Nand said, referring to the New Market case. "From now, prior permission is required for holding victory processions."

The Kolkata top cop also asked citizens not to believe in hearsay or fake news.

DGP Gupta said 200 FIRs had been filed post-election, leading to arrest of 433 individuals.

2 minor girls kidnapped from Maharashtra rescued in UP: Police have rescued two minor girl cousins from Ballia in Uttar Pradesh, a month after they were abducted from Maharashtra's Beed district, officials said on Wednesday. The main accused, Vijay Mahadev Kavhle, a resident of Nanded district in Maharashtra, was apprehended from UP on Tuesday in a coordinated interstate operation conducted over four days, the Beed police said in a release.

Police arrest elderly man accused of molesting his nine-year-old granddaughter: Police have arrested a 70-year-old man hours after he allegedly molested his minor granddaughter at a slum dwelling of Pune city, officials said on Wednesday. The incident, which involved the septuagenarian's nine-year-old granddaughter, occurred around 9.30 pm on Tuesday. The incident sparked tension in the locality as nearby residents and others gathered on the streets in protest.
