Cyberabad police arrest 6 for cyber scam worth ₹77 lakh

Six persons have been arrested from West Bengal by the Cyberabad police, Hyderabad, for running an interstate cyber fraud racket that siphoned off nearly ₹77.75 lakh through voice phishing calls, SIM manipulation, and OTP diversion frauds. The accused allegedly posed as bank officials and contacted victims under the guise of verification procedures. Investigators also recovered ₹15 lakh in cash, bank labels, and electronic devices from the residences of the accused.

Kamal submits six demands to Vijay on film industry

MNM founder and Rajya Sabha Member Kamal Haasan on Saturday met Tamil Nadu CM C. Joseph Vijay and handed over a list of six demands for the development of Tamil film industry. Mr. Haasan's meeting with Mr. Vijay comes a day after the former called for talks with stakeholders regarding the adoption of "practical and sustainable film-making practices". "Today, I met with the Honorable Chief Minister and younger brother Vijay, and conveyed my best wishes and submitted six demands."

HC criticises bank for freezing educational society's accounts

A bank cannot assume the role of an adjudicating authority and proceed to freeze accounts of an educational society merely on the basis of internal disputes between rival factions of the society, the Karnataka High Court has said. The case relates to Sri Venkataramana Swamy Vidyavardhaka Sangha at Bantwal in Dakshina Kannada district. "Ordinarily, debit freezing of accounts can be justified only when it is backed by authority of law," the court observed.

HC relief for personnel of STF formed to arrest Veerappan

It holds that the appellants participated in risky operations, and says the State govt. should not recover the benefits derived by them during their service as SIs from the date of their promotion

Granting relief to police personnel who were part of the Special Task Force (STF) constituted by the government to nab forest brigand Veerappan, the Madurai Bench of the Madras High Court said the State should not recover the benefits derived by them during their service as Sub-Inspectors (SIs) from the date of their promotion.

The court was hearing the appeals filed by the police personnel against an order of the Single Bench of the court. The appellants challenged a G.O. and the consequential order reverting them to a lower post. The Single

Bench of the court had dismissed their petitions. The appellants were originally appointed as constables in 2002. They were promoted as Naik in 2004. The reafter, within a short span of five months, they were promoted as Havildar on a temporary basis. At the time of promoting the appellants on temporary basis, it was clearly indicated that the promotions were purely on a temporary basis, and the same will not confer any right or merit to further promotion etc.

Following the killing of Veerappan and his gang in 2004, the government issued a G.O., granting one stage accelerated promotion to over 900 police personnel of various ranks. Later, the government is-

sued a G.O in 2009 clarifying the position that the accelerated promotion is not extended to accelerate seniority and indicated that the seniority between the accelerated promotees and general promotees in the promoted category shall continue to be governed by their panel position.

At no stage shall accelerated promotion confer accelerated consequential seniority on an individual, since such promotion is only for one stage. The appellants who were granted accelerated promotion and promoted as SIs were reverted to the rank of Naik in 2009 as they were officiating only on a temporary basis at the time of grant of accelerated promotion. The G.O. and the

consequential reversion orders were challenged.

Merely because accelerated promotions were mistakenly granted, the appellants cannot now contend that they are entitled to seniority on that basis. Consequently, they were rightly reverted. Accelerated promotion is, in fact, intended to be granted only against a substantive vacancy, the court said.

The court said it was of the view that since the promotion was wrongly granted by the State, and as the appellants also participated in risky operations as part of the STF, all the benefits derived by the appellants during their service as SIs from the date of their promotion should not be recovered by the State.

Minister's son held in POCSO Act case

After a week-long manhunt, Bandi Bageerath, son of Union Minister for Home Affairs Bandi Sanjay, was arrested by Cyberabad police on Saturday night, in connection with a Protection of Children from Sexual Offences (POCSO) Act case booked against him at the Petbasheerabad Police Station.

According to Cyberbad Police Commissioner M.

Ramesh, he was apprehended at the TGPA junction at around 8 p.m. and was taken to the Narsingi police station in Telangana first. He was later shifted to Petbasheerbad for post arrest formalities.

Officials said he would undergo mandatory medical examination procedures before being produced before a court for remand. The accused had remained untraceable since the case was registered on May 8 following a

complaint lodged by the mother of a 17-year-old girl, who had accused him of sexually assaulting and emotionally manipulating her daughter over several months. Union Minister of State for Home Affairs Bandi Sanjay in a statement issued late on Saturday said, "All are equal before the law. All should abide by the rule of law."

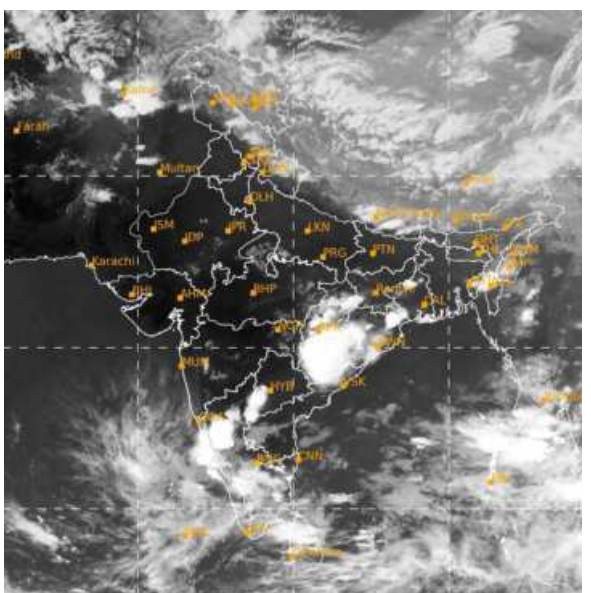
"In fact, I thought of handing him over at the police station soon after a complaint was lodged. The

lawyers, after examining the evidence, said that the case will be quashed and bail will be granted. As a result, a slight delay occurred."

The arrest had made following the Cyberabad police's intensified efforts to trace him by deploying five special teams, carrying out searches at residences linked to him in Hyderabad and Karimnagar, and issuing a lookout circular to prevent him from leaving the country.
