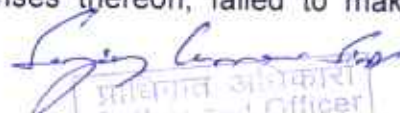

Pihu Autoconcept availed OD Loan – SME Secure facility from Indian Bank, Jhumri Telaiya Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". As M/s. Chandan Kumar Singh and M/s. Pihu Autoconcept failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **11.03.2026** after complying with all legal formalities.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

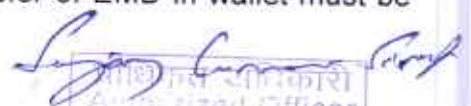
The date of sale is fixed as 18.06.2026 which would be by e-auction mode.

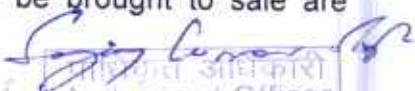
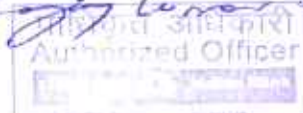
