

AISF protests against NEET paper leak, accuses Modi of betraying students

The police used water cannons to disperse a spirited All India Students' Federation (AISF) protest in Thrissur on Friday, as the outfit escalated its attack on the Union government over the NEET-UG paper leak. Tensions flared as AISF activists marched to the BSNL office.

‘Students betrayed’
Inaugurating the protest, AISF State joint secretary Aslam Shah strongly criticised Prime Minister Narendra Modi, accusing the Centre of betraying students. “Casting a shadow over the dreams of 57 lakh stu-

dents is an unforgivable crime. There can be no pardon for Narendra Modi,” he said, warning that a larger “Gen Z protest”

would emerge against the government. Sharpening his criticism, Mr. Shah questioned the Prime Minister’s educational cre-

dentials. “If Narendra Modi cannot produce documents to prove his own educational qualifications, how can he address the crisis in higher education?” he asked. He also alleged that BJP leaders were involved in the NEET-UG paper leak and said the Central government cannot escape responsibility for the controversy. “AISF will lead the fight to protect students’ rights across the country,” Mr. Shah asserted. The protest meet was presided over by AISF Thrissur district president K.S. Abhiram, as police action added to the charged atmosphere of the demonstration.

Operation Numkhor: Customs seize 8 SUVs from across State

The Customs (Preventive) Commissionerate, Kochi, seized seven SUVs in connection with Operation Numkhor —a nationwide crackdown on the large-scale smuggling of premium second-hand vehicles through Bhutan and forged registration rackets involving Motor Vehicle Department (MVD) officials—from across Kerala and arrested one person on Thursday. The arrested was identified as Zain Marva, partner of Roadway Cars, Kozhikode. He was accused of maintaining direct links with smuggling gangs and selling such SUVs across Kerala. Investigators found that Biswajit Das, the al-

leged kinpoin of the racket who sourced many smuggled SUVs from Bhutan, had sold several of these vehicles to Roadway Cars through a Delhi native. Mr. Das, believed to be one of the masterminds, was apprehended near the India-Bhutan border in a coordinated operation on February 22. He was remanded in judicial custody and later brought to Kochi on transit remand for further investigation. The Customs charged Mr. Marva under provi-

sions of the Customs Act for his alleged involvement in smuggling seven SUVs, valued at over ₹1.50 crore, from Bhutan to Kerala. In a related development, a Nissan Patrol car that featured in the movie *Lucky Bhaskar* starring Dulquer Salmaan was seized from Eldo Paul of Signature Cars, Kalamassery. The seizure was based on the reasonable belief that the vehicle had been illegally imported into India through the Bhutan/Nepal borders, a release issued by the Customs here on Friday said. The Customs (Preventive) Commissionerate, Kochi, has drawn up a potential list of 200 smuggled vehicles across Kerala.

Transgender man allowed to approach fertility clinic to freeze eggs

The Kerala High Court has permitted a transgender person to approach any fertility centre to freeze and store his eggs. The 28-year-old transgender man approached the High Court after a private fertility centre refused to provide the service. The centre cited that the Assisted Reproductive Technology Act did not contain any provision to permit the extension of such a service to a transgender. The court directed that the clinic take the person ought to take steps to preserve his eggs.

Amoebic fever: two under treatment

The Health department on Friday confirmed another case of amoebic meningoencephalitis in Kozhikode district. The infection was confirmed in a 19-year-old-boy from Feroke, who had been admitted to the Government Medical College Hospital, Kozhikode. He had been reportedly working with a private firm in Alappuzha. With the latest case, the number of patients under treatment for the infection in the district went up to two, including a nine-year-old boy from Kottur panchayat. Hospital sources said both patients are stable and responding to treatment. Amid concerns over fresh infections, the Health authorities have stepped up preventive and surveillance measures with focus on water quality and sanitation activities. Samples have been collected from multiple locations for laboratory analysis to identify potential sources of contamination. All agencies involved in water supply and distribution have been instructed to ensure that adequate residual chlorine levels are maintained in drinking water systems.

The directive also applies to operators of swimming pools at resorts and water-theme parks.

Satheesan slams hate campaign, vows firm stance on secularism

Kerala Chief Minister-designate V.D. Satheesan has issued a stern warning against communal polarisation. He also asserted that his government would not compromise on attempts to disrupt the secular fabric of Kerala. Speaking to mediapersons at the Cantonment House on Friday, Mr. Satheesan lashed out at attempts to portray the Indian Union Muslim League (IUML) as a non-secular entity. Claiming that such moves were part of a calculated hate campaign, the Congress leader stressed that the IUML has been a major constituent of the United Democratic Front (UDF) since the times of K. Karunakaran. Besides, the party’s contribution was instrumental in the coalition’s electoral victory. According to him, the attacks on the IUML is a strategic attempt to create

a social divide. He warned that if the IUML was weakened, the resulting political vacuum would be filled by radical communal forces. The party served as a vital political barrier against such extremism, he said. **Secular credentials** Mr. Satheesan accused the BJP of consistently utilising communal propaganda to incite division at both the State and national levels. While acknowledging that certain community organisations may have personal grievances against him, he made it clear that he would not tolerate the spread of communalism. The UDF did not compromise its values for electoral gains and would continue to stand firm on its secular credentials. “Kerala has sent a clear message to the nation that we are a secular State. We will not allow a single scratch on that identity. No force will be permitted to destroy the harmony in which our future generations must live. We will resist such attempts at any cost,” he said.
