

Seminar highlights role of technology in tribal development

As part of the ‘Janjatiya Garima Utsav’ celebrations, the Kerala Institute for Research, Training and Development Studies of Scheduled Castes and Scheduled Tribes (KIR-TADS) on Friday organised a one-day seminar on ‘Tech-driven sustainable Scheduled Tribe development in the era of AI’. The sessions focussed on the role of artificial intelligence (AI) and emerging technologies in strengthening tribal development initiatives and improving livelihoods. KIRTADS Director S. Bindu, who inaugurated the seminar, stressed the need to integrate AI and other modern technologies into development planning to promote sustainable progress and improve the quality of life of tribal communities. P. Sasikumar, Assistant Director (Sub Plan Cell), Directorate of ST Development, presided over the session.

A series of technical sessions was held under the leadership of a five-member panel. The discussions covered AI-driven mitigation of human-wildlife conflict, socio-economic planning for tribal welfare, inclusive digital technologies for empowerment, cyber security, and preservation of tribal languages through AI.

The programme coordinators said 73 participants, including officials from the ST Development department and representatives of tribespeople, attended the sessions. K.S. Pradeepkumar, Deputy Director (Training), KIRTADS, welcomed the resource persons and participants.

Kadirur panchayat bags Atma Nirbhar award

Kadirur grama panchayat in Kannur has secured the third position nationally in the ‘Atma Nirbhar Panchayat Special Award’ category of the National Panchayat Awards 2026 announced by the Ministry of Panchayati Raj. The award recognises achievements during the 2024-25 appraisal year. Kadirur was selected from among nearly 2.68 lakh panchayats across the country.

The panchayat earned recognition for its comprehensive initiatives in poverty alleviation, healthcare, women empowerment, waste management, infrastructure, and good governance. Through agriculture-based schemes, Kudumbashree activities, and the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS), the panchayat strengthened livelihood opportunities and reduced the number of Below Poverty Line families from 1,917 in 2009 to 1,440 in 2021-22, with only 38 families remaining in extreme poverty.

The panchayat also received appreciation for its healthcare network. Kadirur achieved the first place in the State’s Clean and Green Panchayat rankings in 2022 and 2025.

The panchayat has also implemented child-friendly and women-friendly initiatives.

Fuel delivery delays spark concerns across north Kerala districts

An alleged cut in fuel supply by some oil marketing companies following the latest price hike has raised concerns among petrol pump owners in the northern districts, with dealers warning that prolonged disruption could lead to the temporary closure of outlets.

Petrol pump operators in Kozhikode, Wayanad and Malappuram districts said many outlets were facing unexpected fuel supply disruptions, affecting their regular operations. Some dealers in Kozhikode alleged that the restrictions began soon after reports of the latest fuel price hike surfaced.

According to dealers, fuel companies were delaying deliveries despite ad-

vance payments for stock already having been made. “They are citing technical issues and refinery-related problems to delay supplies. We are facing an unpredictable business situation,” a pump owner in Kozhikode city said.

He also claimed that the restriction had affected several local petroleum dealers who mainly depend on Hindustan Petro-

leum Corporation Limited (HPCL) depot at Elathur. Owing to stock shortages, a few fuel stations had already been forced to suspend operations temporarily, he said.

Hameem Parayangatt, a petroleum bunk owner in Malappuram, said the declining fuel stock could eventually affect vehicular movement and disrupt essential services. “Petroleum dealers are deeply concerned over the unexpected situation. We are now forced to reserve the available stock for emergency needs,” he added.

Libineesh Kunnath, district secretary of the Kozhikode District Petroleum Dealers Association, alleged that the State was witnessing clear instances of hoarding and black marketing by some oil companies.

“The situation is likely to worsen in the coming days, with fuel prices expected to rise further under the prevailing circumstances. We have already raised the issue with representatives of the oil companies and sought immediate corrective measures,” he said. Stakeholders in other sectors also expressed concern over the possible impact of the fuel shortage and rising prices.

Meanwhile, representatives of some oil companies, including HPCL, said the present situation was the result of various war-related regulations and that oil companies had only a limited role in taking independent decisions. They also denied allegations by dealers that fuel supply had been restricted following the latest price hike.
