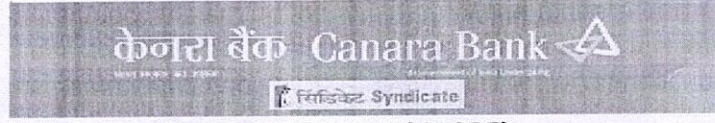
k. All charges for conveyance, stamp duty and registration, GST etc., as applicable, shall be borne by the successful bidder only.
