M/S SAMBASHIVA COTTON INDUSTRIES, represented by present partners Mr B Maruti & Mrs B Sharada failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 20.02.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) referred as above liable to the Bank to pay the amount due to the tune of Rs.38.83,027/- (Thirty eight lakhs eighty Three thousand and Twenty Seven rupees only) as on 20.02.2026 with further interest, costs, other charges and expenses thereon. 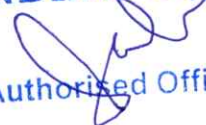
