Therefore a Demand Notice dated 19.10.2024 under Sec. 13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s) and Guarantor(s), liable to the Bank to pay the amount dues to the tune of Rs. 62,46,378/- (Rupees Sixty Two Lakhs Forty Six Thousand Three Hundred and Seventy Eight only) (OD Ind SME Secured loan : Rs 50,75,621/- and RBD Term Loan : Rs 11,70,757/-) as on 19.10.2024 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 20.10.2024.
