2. EMD Payment: The intending Bidders/Purchasers are requested to register on portal (<https://ebktray.in>) using their email-id and mobile number. The process of e-KYC is to be done through Digilocker and after completion of KYC verification; the intending bidders/purchasers may login and make the EMD payment. For EMD payment also by way of creating challans and by depositing the amount in the wallet. The payment must be ensured well in advance before the stipulated time. 9. The success auction Purchaser/Bidder shall have to deposit 25% (twenty five percent) of the bid amount (i.e. including EMD amount deposited earlier) immediately on finalization/concluding of Auction i.e. on the same day or not later than next working day. The balance amount of bid/purchase price payable shall be paid by successful auction Purchaser/Bidder to the Authorised officer on or before fifteenth day of confirmation of sale of the property or such extended period as may be agreed upon in writing between the purchaser and secured creditors, in any case not exceeding three months.
