to pay the amount due to the Bank, being **Rs.9,17,135/92 (Rupees Nine Lakhs Seventeen Thousand One Hundred Thirty Five and Ninety Two Paise only)** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment within 60 days from the date of receipt of the said notice.





Whereas the borrower & guarantors having agreed to pay the amount due in full to the Bank as called for in the said demand notice, the Bank has taken possession of the secured assets more fully described in the schedule hereunder on **08/12/2025** under Section 13(4) of the Act with the rights as set out in "As is where is", "As is what is" and "Whatever there is" back under Section 31(3) of the Act read with Rules 8 & 9 of the Security Interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as **Rs.9,39,276/- (Rupees Nine Lakhs Thirty Nine Thousand Two Hundred and Seventy Six only)** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on **20.04.2026** works out to **Rs.9,86,780/- (Rupees Nine Lakhs Eighty Six Thousand Seven Hundred and Eighty only)** after reckoning repayments, amounting to **Rs.24,237/-** subsequent to the Bank issuing demand notice.

The undersigned in exercise of the powers conferred under Sec. 13(4) of the said Act proposes to realize the Bank's dues by sale of the under mentioned properties.

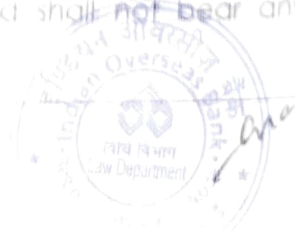

2. The intending Bidders /Purchasers are requested to register on portal <https://baanknet.com/> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his **Global EMD Wallet account by 27.05.2026 at 5.00 P.M.** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.

3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/RTGS mode (After generation of Challan from <https://baanknet.com/> which will provide account details) in bidders Global EMD Wallet account. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. Bids without EMD shall be rejected summarily. The Earnest Money Deposited shall not bear any interest. The amount of EMD paid by the successful bidder shall be adjusted towards the sale price.

10. The balance amount of sale price shall be paid within 15 days from the date of confirmation of auction sale. Failure to remit the entire amount of sale price within the stipulated period will result in forfeiture of deposit of 25% of the bid price to the secured creditor and forfeiture of all claims over the property by the purchaser and the property will be resold.

11. The sale certificate will be issued in the name of the successful bidder (purchaser) only, after payment of the entire sale price amount and other taxes/charges, if any.
