M/s Master Trade India Ltd (Proprietorship Concern) Prop : Pralay Sinha Roy (Proprietor/Mortgagor) availed credit facilities from Indian Bank(erstwhile Allahabad Bank) Chakraberia Branch, the repayment of which is secured by Mortgage of schedule mentioned property/ies hereinafter referred to as "the Property/ies". M/s Master Trade India Ltd (Proprietorship Concern) Prop : Pralay Sinha Roy (Proprietor/Mortgagor) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 07.12.2011 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Mortgagor(s) for payment. M/s Master Trade India Ltd and its Proprietor were liable to the Bank to pay the amount due to the tune of Rs 78,68,035.00 (Rupees Seventy Eight Lacs Sixty Eight Thousand Thirty Five only) as on 30.11.2011 with further interest, costs, other charges and expenses thereon. All of the above persons failed to make payment despite Demand Notice dated 07.12.2011 was issued.

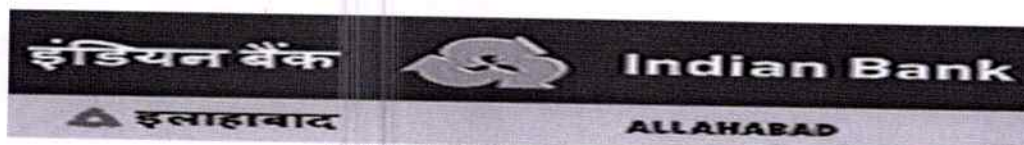

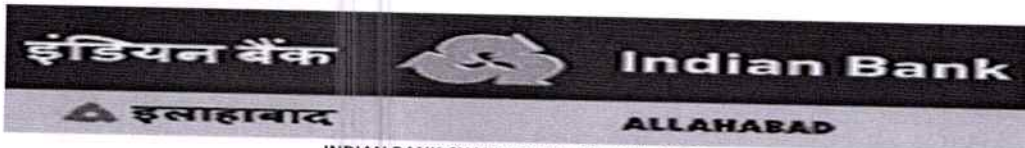
