Mr. Aneet Kumar Verma S/o Mr. Ram Prakash Verma availed Cash credit facility from Indian Bank (e-Alb), Etawah Main Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Aneet Kumar Verma S/o Mr. Ram Prakash Verma failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 23.11.2016 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower Mr. Aneet Kumar Verma S/o Mr. Ram Prakash Verma, Guarantor(s)---liable to the Bank to pay the amount due to the tune of **Rs.911753+INT** (Rupees Nine Lakh Eleven thousand Seven hundred Fifty Three Only) as on 10.08.2016 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 23.11.2016

As Mr. Aneet Kumar Verma S/o Mr. Ram Prakash Verma, failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 09.03.2017 after complying with all legal formalities.
