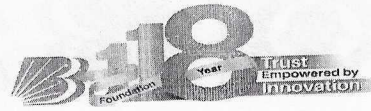

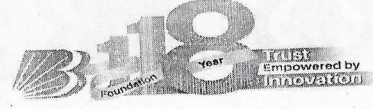

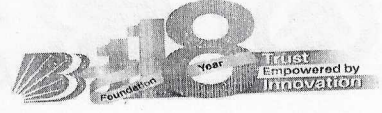
8. 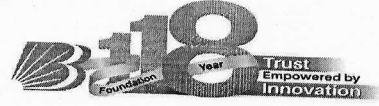
